Dialogues on Canadian Energy

Dennis McConaghy has 30 years of experience in the Canadian energy industry in prominent commercial executive positions that included the commercial development of the Keystone XL pipeline systems within TransCanada Pipelines from its conception in 2006 to the finalization of commercial agreements in 2008.

He is currently a visiting fellow at the public policy and energy studies schools at the Ivey Business School at the University of Western Ontario and an adjunct fellow at the Niskanen Center, a DC based think tank focused on carbon and energy policy. Recently Dennis published a book, "Dysfunction – Canada after Keystone XL", analyzing the Keystone XL experience and its implications for Canada. 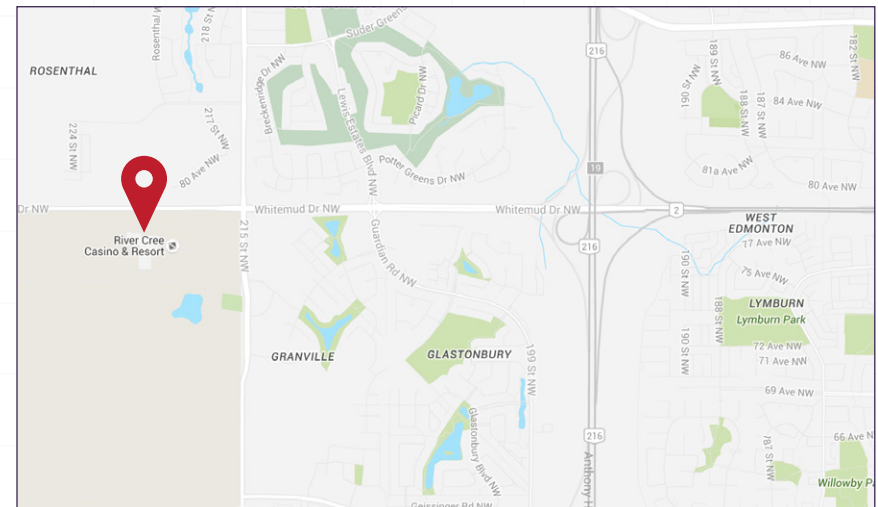
